Introduction

We have published the scheme to meet the requirement of section 19 of the Freedom of Information Act 2000 (FOIA). The purpose of the FOIA is to promote greater openness and transparency by public authorities, and in drawing up our scheme we have taken into account the kind of information requests we have received to date. We will review the scheme at regular intervals and monitor how it is operating.

This Publication scheme is a guide to the information routinely published by NHS Resolution. It is not a list of actual documents, since this will change as new material is produced, but it is rather a description of the classes or types of information available.

The person responsible for the publication scheme on behalf of NHS Resolution is Bunmi Ogunseye, Information Access Manager.

Most publications can be downloaded directly from our website <u>resolution.nhs.uk</u>. At present, all the information we proactively release is available free of charge on our website. If we do not proactively publish certain types of information, we will provide advice on how to request it.

Charging for information

We will explain any charges that you may incur. Charges may be made for information subject to a charging regime specified by Parliament. Charges may be made for actual disbursements incurred such as:

- photocopying
- postage and packaging
- the costs directly incurred as a result of viewing information

Charges may also be made for making datasets (or parts of datasets) that are relevant copyright works available for re-use. These charges will be in accordance with either regulations made under section 11B of the FOIA or other enactments. Information held by NHS Resolution that is not published under this scheme can be requested in writing and will be considered in accordance with the provisions of the FOIA.

You may use and re-use the information featured in this publication scheme (not including logos or photographs) unless identified as another party's copyright free of charge in any format or medium, under the terms of the Open Government Licence. We encourage users to establish hypertext links to NHS Resolution's website. More information about the Open Government Licence can be found on the National Archives website here.
