The following information was requested on 21 October 2020:

- 1. The total number of claims where consent was an issue.
- 2. The details of these cases including settled & outstanding claims & quantum where damages were paid (we would be grateful for as much information as possible but of course appreciate the constraints of sensitive personal data).
- 3. The no of claims where the Montgomery decision was referred to.
- 4. The no of claims/cases involving obstetrics.
- 5. The details of these cases including settled and outstanding claims (subject to constraints in 2).
- 6. The no of claims/cases involving gynaecology.
- 7. The details of these cases including settled and outstanding claims (subject to constraints in 2).
- 8. The no of claims involving consent in cancer.
- 9. The details of these cases including settled and outstanding claims (subject to constraints in 2).
- 10. The no of claims involving consent in women's cancer (breast, uterine, ovarian, cervical, vulval).
- 11. The details of these cases including settled and outstanding claims (subject to constraints in 2).

We appreciate that the coding of causes is completed by claims managers at the time at which a claim is notified and that this may change during the course of a claim as the settled facts emerge.

#### **Our Response**

We only hold claims data for England (our schemes only cover England), not the UK.

Although NHS Resolution may hold some information relating to claims such as these, due to the way claims are recorded on our claims database, we will not be able to identify such specific cases. It might be helpful to explain that when claims are notified to NHS Resolution they are categorised against pre-defined cause, injury and speciality codes, unfortunately women's cancer (breast, uterine, ovarian, cervical, vulval) or claims where the Montgomery decision was referred to is not one of these. Therefore, while there may be information held in our records, we are not readily able to identify the relevant files by searching the database. To do so would involve a review of all cases to identify which ones relate to claims involving women's cancer (breast, uterine, ovarian, cervical, vulval) or claims where the Montgomery decision was referred to. NHS Resolution receives thousands of claims each year.

Therefore, we estimate that the cost of complying with the request in its entirety would exceed the 'appropriate limit'. Section 12(1) of the FOIA is a provision which allows a public authority to refuse to comply with a request for information where the cost of compliance is estimated to exceed a set limit (known as the 'appropriate limit'). The 'appropriate limit' for NHS Resolution is £450. This equates to 18 hours of work at the rate of £25 per hour set out in the 'Fees Regulations'.

We estimate that it would take on average 10 minutes to locate, retrieve and extract the requested information from an individual file. It may therefore be the case that we would be able to examine only 108 files within 18 hours.

Please **find attached** the information we are able to provide in respect of consent claims.

We have supressed low figures and we are unable to provide details of individual cases as we believe that disclosure of information with this level of granularity is exempt under Section 40(2) by virtue of section 40(3)(a)(i) of the Act, where disclosure to a member of the public would contravene one or more of the data protection principles. The data protection principles are set out in Article 5 of the General Data Protection Regulation. We take the view that it would not be fair or lawful (given the sensitive and confidential nature of the information held) to disclose such information, and any disclosure would therefore contravene the first data protection principle.

In some instances the low numbers of claims (fewer than 5) in each category, the likelihood exists that individuals who are the subject of this information may be identified either from this information alone, or in combination with other available information. In addition to this, as this information is considered to be sensitive personal data (the data subjects' medical condition); NHS Resolution believes it has a greater responsibility to protect those individuals identities', as disclosure could potentially cause damage and/or distress to those involved. Where we are in the territory of such small numbers in the attached, we have used a '\*, symbol in the relevant field. You should still be able to see aggregate/total details for higher level fields containing this data.

Further to our obligations to provide advice and assistance, you may find it helpful to review the work of the <u>Getting It Right First Time team</u> with whom NHS Resolution has been working with to undertake in-depth analysis of our claims data. They have produced a number of <u>reports</u> from analysing our claims data which has been shared following approval of the confidentiality advisory group to the use of confidential patient information for this purpose.
